*For publications after 8/6/2017, 1st author or corresponding author and for publications before 8/6/2017, 1st author or 2nd author is accepted.

** Outside state candidates should get their qualification registered from Telangana State Medical Council within one week of selection, for their appointment to be confirmed.

Proof of the senior residency period should be produced and attached to the application form.

Note:

1. Age and all other qualifications will be counted as on the last date of submission of online application.
2. DNB Candidates will be selected as per the latest existing MCI guidelines.
 - a) If already promoted as Professor or Associate Professor and accepted by MCI in the previous assessments, they are eligible to apply.
 - b) If applying for post of Assistant Professor then, post DNB, 3 years as Junior Resident in a recognized medical college in the concerned subject and 1 year as Senior Resident in the concerned subject in a recognized medical college is mandatory. (Proof in the form of bank statements or form 16 for the 4 years to be attached along with application form).
3. Selection of candidates will be nationwide. Telangana candidate will be given preference.
4. The age of the applicant should be below 45 years. (Upper Age Limit: 45 (Forty Five) years).
5. The candidates should not have appeared for any MCI assessment for the academic year 2021-22.
6. The candidates who have joined in any other Government Medical Colleges of Telangana on Contract basis are not eligible for Applying.
7. During the period of contract, the faculty will be paid a consolidate monthly remuneration depending upon the post as per GO. Rt.No.452 Health, Medical And Family Welfare (B1), Government of Telangana, dated 03/08/2018. The remuneration shall be all inclusive and subject to deduction of tax at source and/ or any other statutory deductions to the extent required under the laws.

TERMS AND CONDITIONS FOR APPOINTMENT ON CONTRACTUAL BASIS (ASSISTANT PROFESSOR)

1. The appointment is purely on CONTRACT BASIS for a period of One Year (12 months) or till such time the alternate arrangements are made, whichever is earlier, with effect from the date of joining. However, the contractual appointment shall not be extended beyond the period of two years. If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's remuneration, without assigning any reason or failure to complete the period of three months to the satisfaction of Competent Authority.
 - a) The appointment is purely on temporary basis and will not have any right of service for regular appointment.
 - b) This contract appointment will not confer any right to him/her for regularization of services
2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
4. The appointee shall not be granted any claim or right for regular appointment to any post of MNJIO&RCC, Hyderabad.
5. The appointee shall be on the whole time appointment of the MNJIO&RCC, Hyderabad and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. The appointment to the said post will be subject to medical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority.
7. Leave entitlement of the appointee shall be governed as per Telangana Government contractual appointment terms and Conditions.
8. On appointment, the appointee will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma.
9. The engaged faculty and technicians will be at the disposal of the Institute on whole time basis and his/her service may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional remuneration.
10. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
11. Other conditions of service will be governed by relevant rules and orders issued from time to time.
12. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such

14. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the MNJIO&RCC, Hyderabad.

21. The candidate should not have been convicted by any Court of Law.
